Failure to file, to request an additional extension of time to file (up to a maximum of six months from the original due date), or to notify our office, in writing, on or before November 15, 2025 that you no longer intend to solicit in Virginia, may result in the issuance of a press release warning the public that you have not complied with the law, as outlined in Section 57-52 of the Code of Virginia.
